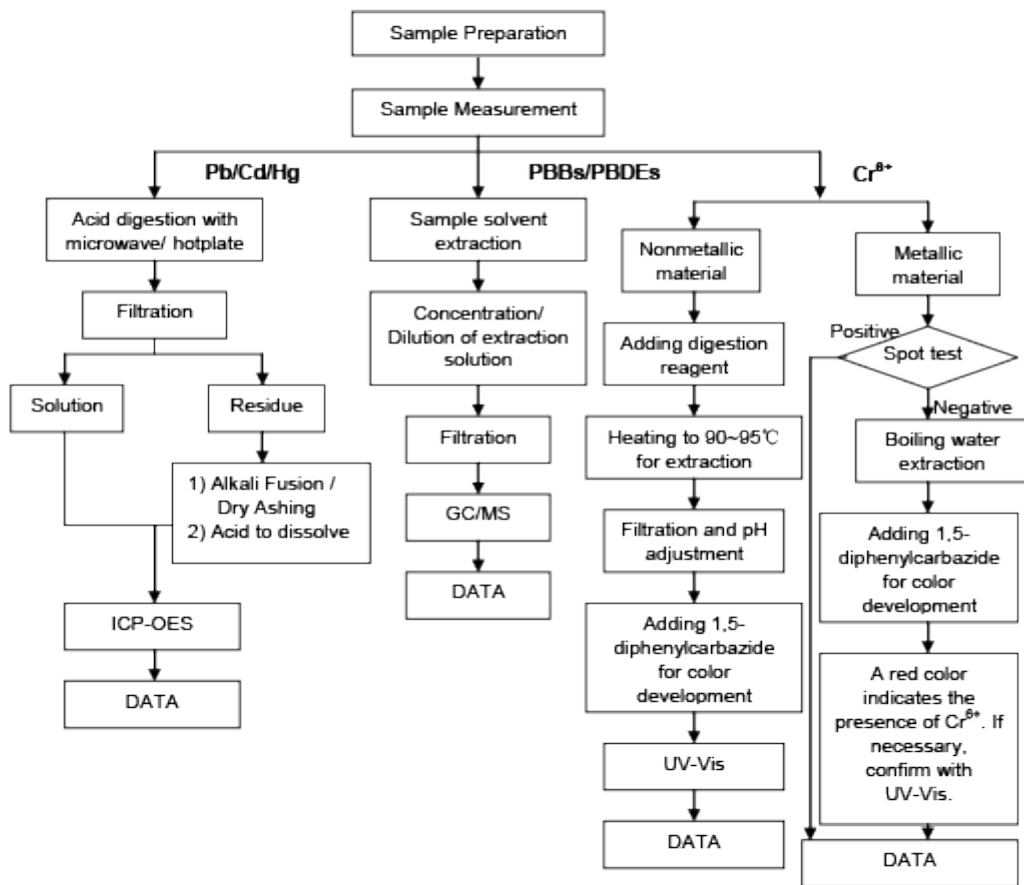

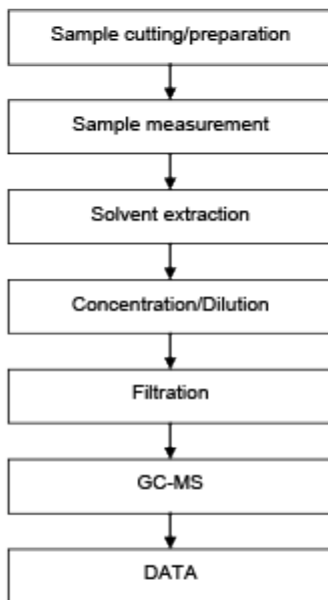

**Phthalates Testing Flow Chart**

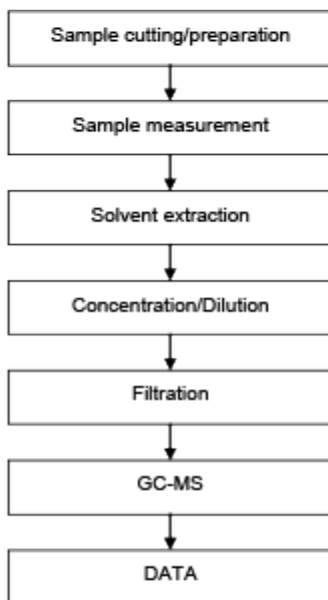

**HBCDD Testing Flow Chart**

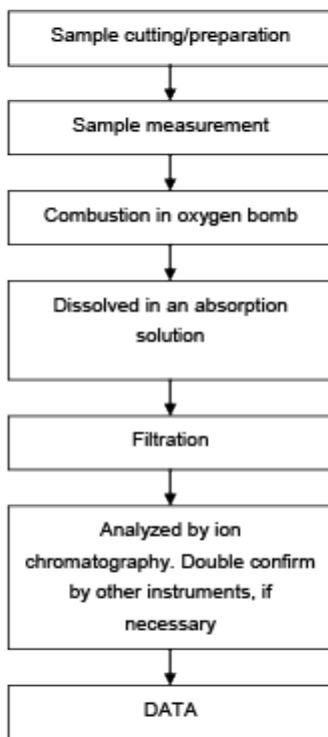

**Halogen Testing (oxygen bomb) Flow Chart**

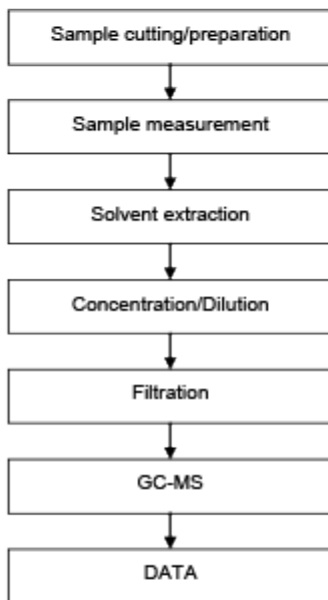

**PAH Testing Flow Chart**

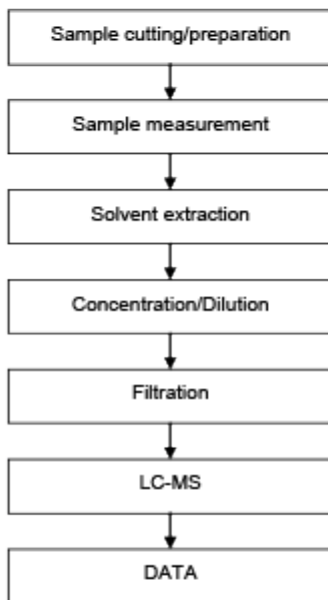

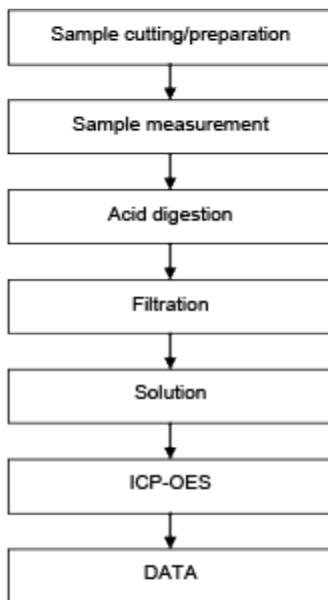
